In compliance with SEC regulations, we would like to disclose the following information regarding Philippine Savings Bank's (PSBank) financial results for year-end 2016.

PSBank reports P2.45 Billion in Net Income for 2016

Philippine Savings Bank (PSBank), the thrift bank arm of the Metrobank Group, posted a full year net income of PhP2.45 billion in 2016, higher than the PhP2.35 billion recorded in the previous year. This translated to a return-on-average equity of 12.5%. The increase was fueled by the Bank's core income, composed of net interest margin and fees and commissions, which rose by 11.6% to P10.80 billion from P9.68 billion last year.

The Bank's total loan portfolio continued to post double-digit growth year-on-year, rising by 11.4% to PhP129.2 billion from PhP116.0 billion, mainly driven by the significant increase in Auto and Mortgage loans. Despite the expansion of its loan portfolio, PSBank was able to keep its net non-performing loans (NPL) ratio in check at 1.1% with NPL coverage at 88.6%.

On the funding side, total deposits grew by 17.9% to PhP158.39 billion from PhP134.30 billion, with low cost funds increasing by 19.1%. By end-2016, PSBank's total resources expanded by 16.3% to PhP196.9 billion. The Bank's Tier 1 and total capital adequacy ratios stood at 11.1% and 14.1%, respectively. Both are above the minimum required level set by the Bangko Sentral ng Pilipinas.

"2016 was a good year for PSBank. Aside from strengthening our core business, the Bank was also conferred with several new and back-to-back recognitions from local and international award-giving bodies, acknowledging our ability to come up with innovative product offerings and provide exceptional end-to-end customer experience. Such recognitions drive us to continue to provide the best banking experience to our clients with products and services that are simple and reliable," PSBank President Vicente R. Cuna Jr. said.

PSBank was ranked second strongest bank in the Philippines by The Asian Banker in its AB500 annual ranking 2016-2017 Edition. This is PSBank's 6th year on the list of Asian Banker's top 10 strongest banks in the Philippines, and is the only thrift bank on the list. PSBank was also given the Pagtugon Award for the second straight year by the BSP for its excellence in responding and addressing its clients' concerns. Awards and recognitions were also given in 2016 for PSBank LiveChat and PSBank Mobile App v2.0, equipped with the ATM Lock feature. The bank was also named one of the best companies in Asia for Customer Experience Management, bagging awards at the annual Customer Experience Awards held in Singapore last September 2016.
