INVESTMENT OBJECTIVE AND STRATEGY

To achieve liquidity and generate income for its participants by investing in a diversified portfolio of short-term Philippine peso denominated fixed income instruments with a portfolio duration of not more than one (1) year. The Fund aims to outperform its benchmark, the Philippine 91-day Treasury Bills (net of taxes).

CLIENT SUITABILITY

KEY RISKS AND RISK MANAGEMENT


PSBank Money Market Fund uses a defined Risk Management policy in identifying and measuring level of risks. The Fund uses weighted modified duration in evaluating market risk for investment in fixed income securities. Modified Duration measures the approximate sensitivity of the value of the security to changes in interest rates. Interest rates have an adverse relationship with fixed income security prices so that an increase in interest rates generally leads to decrease in fixed income prices and vice versa. The higher the duration of an instrument, the higher its risk (considering all other factors are equal).



OTHER DISCLOSURES

1) RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper amounting to Php 86,944,222.58 which were approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

2) LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven

- a) Bank deposits and such other investments allowed under regulations issued by the BSP.
- b) Tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP.
- c) Tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and such other tradable investment outlets/categories as the BSP may allow.

OUTLOOK AND STRATEGY

Month-on-month, yields on government securities decreased by 2.5 bps on the average with the 91-day T-bills closing at 1.095% down by 15 bps for the same period, as markets players remained on the sidelines while most players were seen servicing end user requirement on the short end. Meanwhile, the government plans to borrow P200 billion worth of T-bills and T-bonds in January, higher by 65% or P130 billion vs. the P70 billion last month. The Fund's 30-day and year-to-date absolute performance was at 0.077% and 0.594% vs. benchmark of 0.077% and 0.947% respectively. Inflation in December declined to 3.6% from 4.2% in November (lower than consensus forecast of 4.1%). This brought the average headline inflation for full year 2021 to 4.5%, above the BSP's target range of 2.0-4.0%. Core inflation for the month was lower at 3.0% from 3.3% in November with 2021 average core inflation at 3.3%. The lower headline inflation was mainly due to a slower increase in food and non alcoholic beverage prices and a slower increase in the fuels and transportation sector. However, inflation rates were higher in the housing, water, and electricity indices. The lower than expected inflation will give the BSP room to continue to keep interest rates low to support the economy. However, inflation may rise in the shortterm due to the effects of typhoon Odette on food supply and other supply chain disruptions resulting from the COVID Omicron variant. As such, the Fund will continue to invest in high yielding short-term instruments such as T-bills and will take any market opportunities for any upticks in yields to maximize returns.
