INVESTMENT OBJECTIVE AND STRATEGY

To achieve liquidity and generate income for its participants by investing in a diversified portfolio of short-term Philippine peso denominated fixed income instruments with a portfolio duration of not more than one (1) year. The Fund aims to outperform its benchmark, the Philippine 91-day Treasury Bills (net of taxes).

CLIENT SUITABILITY

KEY RISKS AND RISK MANAGEMENT

Modified Duration measures the approximate sensitivity of the value of the security to changes in interest rates. Interest rates have an adverse relationship with fixed income security prices so that an increase in interest rates generally leads to decrease in fixed income prices and vice versa. The higher the duration of an instrument, the higher its risk (considering all other factors are equal).

COOLING-OFF PERIOD


Subject to exemptions under BSP regulations governing the mandatory cooling-off period, the TRUSTOR/s is/are entitled to a cooling off period of two (2) banking days from the date of initial participation (the "Cooling-Off Period") in the applicable FUND. Should the TRUSTOR/s decide(s) to avail of their right to Cooling-Off period, the TRUSTOR/s hall give the TRUSTEE/MANAGER a written notice to cancel within such 2-banking day period. In which case, the TRUSTEE/MANAGER shall refund or return to the TRUSTOR/s the amounts invested, including the documents submitted, without undue delay and within a maximum period of fifteen (15) banking days after receipt of such notice to cancel and shall charge and withhold from said refund such processing fees or charges that are not greater than the actual or reasonable approximation of administrative costs incurred by the TRUSTEE as recovery thereof. As a result of the cancellation, the TRUSTOR/s understand(s) that such a cancellation may also result in mark to market gain or loss depending on the prevailing NAVPU which shall be for the TRUSTOR/s' own account. Otherwise if the TRUSTOR/s fail to exercise such a right within the said Cooling-Off period, the cancellation of investment beyond which shall be treated as a normal redemption subject to the applicable early redemption penalty.



1) RELATED PARTY TRANSACTIONS

The Fund has deposits with the Bank Proper amounting to Php79,819,328.24 which were approved by the Trust Committee. Likewise, all related parties transactions are conducted on an arm's length basis.

2) LIST OF PROSPECTIVE INVESTMENTS

The following are among the Fund's approved investment outlets, wherein the Trustee intends to invest depending on strategy, availability, or other market-driven circumstances:

- a) Bank deposits and such other investments allowed under regulations issued by the BSP.
- b) Tradable fixed-income instruments issued or guaranteed by the Philippine government or the BSP.
- c) Tradable fixed-income instruments issued by financial institutions or private corporations; exchange-listed securities; marketable instruments that are traded in an organized exchange; loans traded in an organized market; and such other tradable investment outlets/categories as the BSP may allow.

OUTLOOK AND STRATEGY

Month-on-month, yields on government securities declined by 69 bps on average with the 91-day T-bills closing at 5.42% down by 73 bps for the same period following the lower T-bills auction results across all tenors last November 28 and lower borrowing plan for the month of December. The government plans to borrow Php60 billion worth of T-bills and T-bonds in December, Php165Bn lower than the previous month's GS auction. Meanwhile, the Fund's 30-day and year-to-date absolute performance was at 0.386% and 4.108% vs. benchmark of 0.400% and 4.052% respectively, while duration stood at 0.07-year as maturities were re-invested in short term fixed income instruments. Headline inflation in November declined to 4.1% from 4.9% in October (lower than consensus forecast of 4.3%). This is slightly higher than the BSP's target range for inflation of 2.0-4.0%. This brings the average headline inflation from Jan-November 2023 to 6.2%. Core inflation also declined to 4.7% from 5.3% in October. The lower headline inflation figure was mainly due to a slower growth in prices of certain food products and non-alcoholic beverages and lower prices of fuel products despite higher cost of utilities during the month.

The U.S. Federal Reserve is expected to keep interest rates steady during its last meeting this December amid declining U.S. inflation. However, Fed Chair Jerome Powell maintained a cautious stance stating that the Fed plans to keep policy restrictive until it is convinced that inflation is on a sustained downtrend and that the Fed is still prepared to tighten policy further should conditions warrant it. Fed Chair Powell also said that it is too early to speculate on when monetary policy might ease. Meanwhile, locally, the Monetary Board kept key rates steady during the MB meeting last November after raising rates by 25bps in an off-cycle move last October. BSP Gov. Remolona said the MB maintained rates to allow the previous rate hikes to work their way through the economy. However, Gov. Remolona said potential upside risks to inflation remain from higher utilities and transport prices, petitions for minimum wage adjustments, and El Nino effects on food supply. Furthermore, the MB deemed it "necessary to keep monetary policy settings sufficiently tight until a sustained downtrend in inflation becomes fully evident and inflation expectations are firmly anchored." The next MB meeting will be held on December 14th and the MB is expected to keep rates unchanged given the lower-than-expected November inflation. Despite the lower November inflation, the balance of risks to the inflation outlook remain tilted to the upside for 2024 and these uncertainties may contribute to increased market volatility. Lower Any resumption in monetary tightening hike may cause domestic interest rates to rise which, in turn, may lead to lower mark-to-market values in the short-term. As such, the Fund will continue be invested in high yielding short-term fixed income securities to provide greater accruals to the Fund and will maintain a short portfolio duration to lessen the impact of market volatility.
