

In connection with the Annual Stockholders' Meeting (ASM) of the Philippine Savings Bank (PSBank) on 25 April 2024 held via remote communication, we wish to advise the Philippine Stock Exchange (PSE) of the following results:

I. ATTENDANCE AT THE MEETING

Pursuant to applicable Securities and Exchange Commission (SEC) regulations, the Bank conducted its ASM via remote communication.

Present in the virtual meeting were stockholders representing more than two-thirds (2/3) of the outstanding capital stock or 88% of the 426,859,416 common shares outstanding as of the ASM Record Date. There was 100% attendance by all nine (9) members of the Board of Directors who had been nominated and elected to their respective positions.
