Minimum bid price for this is the unit's Selling Price. Bids will be tabulated at 9:30am and winning bidders will be announced to the participants immediately thereafter. Bid offer must be submitted/placed inside the bid box starting 8:30am and only until 9:30am. Bid offer to be submitted before the Special Bidding period will not be accepted but instead will be included in the Selling Price Bid Offers.
2. All Special Bidding bid winners shall be required to settle the payment within 2 hours after the awarding of units.
3. Selling Price Offers are treated on a first-come, first-serve basis and is prioritized over bids below the Selling Price.
4. For bids below the Selling Price, all bids will be turned over to ARMU - PSBank Head Office every Tuesday and Friday and will be opened at 2:00pm of the same day for validation and tabulation.
